COMMUNITY CALLS

- Launched ongoing community calls on April 2 with nonprofit and community leaders
- Calls run thirty minutes and feature topics including Unemployment Insurance, small business assistance, CareerForce services, workers protections, assistance for businesses affected by unrest
- DEED is co-hosting some of the calls with other agencies, including the SBA, DLI, DHS and MHFA.
- Calls/meetings with business owners and community leaders in neighborhoods affected by unrest

OTHER COMMUNITY MEETINGS/CALLS

- Ongoing weekly and daily calls with tribal nations and Native-serving organizations and tribal liaisons of other agencies
- 1x weekly call with DLI with workers organizations and unions, providing updates from DEED
- 1x weekly (sometimes more often) calls with DHS focused on specific communities, including refugees, Congolese community, and others.
