- Color Key:
 - Blue are the negotiated performance standards
 - Green means the set goal was met or exceeded
 - Yellow means at least 50% of the goal was met
 - Red means less than 50% of the goal was met
- Served is all participants accessing the program during the actual program year July 1, 2019 – June 30, 2020 (real-time)
- Getting a Job results based on exiters July 1, 2018 – June 30, 2019 except those exited with exclusion. This indicator measures each exiter's employment status during the 2nd quarter after exiting the program. Formula: Percent of employed exiters divided by all exiters during the reporting period.
- Keeping a Job results based on exiters January 1, 2018 – December 31, 2018 except those exited with exclusion. This indicator measures each exiter's employment status during the 4th quarter after exiting the program. Formula: Percent of employed exiters divided by all exiters during the reporting period.
- 2nd Quarter Median Earnings results based on exiters July 1, 2018 – June 30, 2019 except those exited with exclusionary reason and those showing zero earnings. This indicator measures the median earning during the 2nd quarter after exiting the program.
- Credential Attainment results based on exiters January 1, 2018 – December 31, 2018 except those exited with exclusionary reason and those who did not attend credential type training. This indicator measures the percent of participants who received a credential after attending training.
