




## What's At Stake

- The Biden Administration and Congress have shifted from rescue to economic recovery legislation
- President Biden outlined his priorities in the American Jobs and Families Plans
- American Jobs Plan contains infrastructure, broadband, housing, and manufacturing spending proposals as well as \$100 billion for workforce development (over 10 years)
  - This represents a transformational investment as the workforce in Minnesota and across the country adjusts to COVID-19 and other factors like automation
- In addition to this funding advocacy, important to recognize the 'long game' with WIOA reauthorization
- Collectively, we all need to build greater understanding and support for the workforce system

#### **Percent Change in Employment\***

In **Minnesota**, as of **May 05 2021**, employment rates among workers in the bottom wage quartile **decreased** by **28.3**% compared to January 2020 (not seasonally adjusted).

## Workforce Position in Current Legislation

- Bipartisan Senate Infrastructure Deal does not contain direct workforce development funding
- Next steps on infrastructure legislation are unclear in the House
- Speaker Pelosi has repeatedly said she will not bring the infrastructure deal for a vote until the Senate passes reconciliation (could take 2-3 months)
  - Moderate House Democrats will increase pressure for a House vote
- State and local Departments of Transportation will receive significant project funding
  - Proactive outreach from local workforce development boards is critical to enhance partnerships



# **Budget Reconciliation**

The budget reconciliation process deals primarily with federal spending and revenues

- Procedurally, it allows for a simple majority vote in the Senate
- 50-50 Senate presents challenges for Democrats to keep their conference together

Senate Democrats are moving forward with a \$3.5 trillion budget resolution which would implement key parts of the American Jobs and Families Plans

 Following agreement on a highlevel budget resolution, drafting and consideration of legislative text could take 2-3 months Workforce development funding is a key priority for an equitable recovery in this legislative vehicle

 The Senate HELP Committee and House Education and Labor Committee will be critical stakeholders developing the funding and programs within this larger package

## WIOA Reauthorization

- Both House Education and Labor and Senate HELP Committee leadership have agreed to pursue WIOA Reauthorization in a bipartisan manner
  - Positive place to start!
- The House Education and Labor Committee held a series of hearings on various WIOA Reauthorization topics
  - Committees have received comments from stakeholders but have not made significant progress on broad reauthorization topics
- The legislative calendar is very challenging/crowded so WIOA Reauthorization has moved down the priority list
- Department of Labor is a willing partner to congressional offices in this effort
- There will likely be more substantive consideration in Fall 2021

## 2022 Elections

#### **House Control**

- Since the end of World War II, the presidential party has lost an average of 27 House seats in midterm elections
  - Republicans are set to fully control redistricting for about two-fifths of all House seats, while Democrats will only hold sway over one-tenth of them

#### **Senate Control**

- 50-50 Senate leaves little room for error
  - Republicans defending 20 out of 34 seats
- Key states will be NC, NV, NH, GA, AZ, OH, PA, WI, FL
