### Dislocated Worker and Federal Adult Programs

National Dislocated Worker Grants (DWGs)

- Opioids The Minnesota Initiative (OMNI) Program
  - > 60 total participants enrolled with a total of 17 disaster related employment positions filled.
- COVID-19 Disaster Recovery National Dislocated Worker Grant (DWG)
  - > 132 total participants enrolled with a total of 35 disaster related employment positions filled.
- Period of Performance Extension through 6/30/2022 is currently in process. State may request proposed enrollment numbers including Disaster Relief Employment and expansion of types of positions.

### DW Eligibility Policy:

- DOL reviewed the WIOA DW Eligibility policy and provided comments in March 2022. There are still two
  questions pending with the National Office. Once we received a response, the policy will be released for
  public comment period.
- State DW: In internal review. This will also be released simultaneously.
- An email will be sent out to all partners upon release

#### SCSEP:

- RFP to be released this week to bring on two new providers
- TEGL pending

#### WIOA DW, WIOA Adult, and State DW Funding:

- PY22 WIOA Allocations: TEGL pending; allocations will be sent out after TEGL is released.
- State DW Formula: Preliminary allocations will be available mid-late May

### Minnesota Job Skills Partnership Board (MJSP) meeting:

• Scheduled for Monday, June 7, 2022; supplemental funding requests are due by May 7, 2022.

### Carry Forward Requests:

- Providers may request a waiver to carry forward more than 20% of their allocated PY21 funds into the
  nextprogram year using the provided template (attached). Providers who expend or obligate at least
  80% of their PY21 formula funds by the end of the 4<sup>th</sup> quarter do not need a waiver.
- Please submit your waivers by June 7<sup>th</sup> to allow enough time for leadership approval.

## **Adult Career Pathways Programs**

<u>Legislative Direct Appropriation Grants/ Competitive Grants</u>

Quarterly Report templates are posted to each program page on the updated ACP webpage. As a reminder, the reports are due the 30<sup>th</sup> of the month following the end of the quarter (April 30, July 30, October 30, January 30).

The ACP team anticipates beginning to send out workplan documents for SFY23 in early May. We encourage Grantees to begin working on those as soon as possible in order for those to be executed by July 1, 2022.

The team is currently in the process of reviewing the submitted proposals for the **Internationally Trained Professionals** RFP and anticipate award notifications in the next couple weeks.

### Benefits after Training

Please remind customers, especially Spring graduates, about the **Job Search Allowance** and **Relocation Allowance** benefits available for interviews/relocations that are 15 miles or more from the customer's home. Additionally, under 2015 Law, **Reemployment Trade Adjustment Assistance** is available to those who get a new job, are age 50+, are earning \$50,000 or less, and are making less than their layoff wage.
