### Dislocated Worker and Federal Adult Programs

### PY21 data freeze date 07/09/2022:

- This means, all data you'd like included in the PY21 annual performance reports (state and WIOA) will need to be in the system by COB 7/9/2022
  - You can boost performance by capturing your participant's skill gains before 07/09/2022
  - You can boost employment rates by entering supplemental wage information into WF1's Follow-up screen for cases showing "inquire" when running the WF1 CSWIR (Candidate for Supplemental Wage Information report)
    - Do NOT enter supplemental wages if this report does not show "inquire"
    - DEED adds supplemental wages and employer reported wage detail together
      - Entering supplemental wages for cases that will have those same wages reported
         by their employer will artificially inflate wages reported
- The participants included in PY21 performance:
  - 2<sup>nd</sup> Quarter Employment rate: Participants who exited the program 07/01/2020 06/30/2021 (not including those exited with an exclusionary exit reason)
  - 4<sup>th</sup> Quarter Employment rate: Participants who exited the program 01/01/2020 12/31/2020 (not including those exited with an exclusionary exit reason)
  - Median Earnings: Participants who exited the program 07/01/2020 06/30/2021 and have at least \$1 of earnings (not including those exited with an exclusionary exit reason)
  - Credential Attainment rate: Participants who exited the program 01/01/2020 12/31/2020 who
    attended training at any time during their enrollment period (not including those exited with an
    exclusionary exit reason)
  - Measurable Skill Gains: every participant that attended training at any time during the program year (had a training activity open on their case 07/01/2021 – 06/30/2022) must have at least one MSG on their record during that same time or it will be a negative in the MSG measure.

#### **Carry Forward Requests:**

- Total reimbursements through March 2022, for PY21, show 56% of WIOA adult, 63% of WIOA DW and 78% of State DW grantees will most likely need to submit a Carry Forward Request. Be sure to use the most updated form.
- Reminder: Providers may request a waiver to carry forward more than 20% of their allocated PY20 funds into the next program year using the provided template (link below). Providers who expend or obligate at least 80% of their PY20 formula funds by the end of the 4<sup>th</sup> quarter do not need a waiver.
- Thanks to the grantees who have submitted their requests already. Deadline to submit your waiver is June 7<sup>th</sup> to allow enough time for leadership approval.

#### **DWG Extension:**

 Period of Performance (POP) Extension request was submitted for both COVID-19 and Opioids Disaster Recovery Grants. A response is expected from DOL regional office by mid-June. Any modification to statement of work will be requested once the extension is approved.
