

# WHAT IS AN OPI?

The ACTFL Oral Proficiency Interview, or OPI, is a live, 30-minute conversation taking place either on a computer or over the telephone, between a trained and certified ACTFL tester and the candidate. It is a valid and reliable test that measures how well a person speaks a language.

OPI's are conducted through a series of personalized questions, where a sample of speech is elicited and rated against the proficiency levels described in ACTFL Proficiency Guidelines.

OPI's are conducted as an over the phone interview (OPI) or virtual computer interview (OPIc) depending on the target language being tested.


