# <u>Dislocated Worker and Federal Adult Programs</u> (DWFAP)

#### **Grants and Contracts**

- Monthly Financial Status Report (FSR)/Monthly Reimbursement Payment Request (RPR):
  - O Due the 20th day of the month following the preceding month-end. For example, the June RPR/FSR (June 30 end date) is due July 20.
  - o Report accrued monthly expenditures.
  - o A monthly RPR/FSR is required even if no funds were expended.

*Important Reminder*: Per your master contract agreement, funds are to be expended in the cost categories and amounts shown in the approved budget, which identifies allowable costs. As such, grantees need to follow their signed grant agreement, work plans and activity

## Grantee Performance Management System (GPMS):

• Since the transitioning to a new system GPMS, SCSEP is experiencing positive outcomes through collaborative efforts in terms of data collection. The regular GPMS vLive Virtual Office Hours offer real-time communication to create a collaborative environment, encouraging active participation. The GPMS team is actively addressing immediate issues and documenting those requiring further research or technical solutions, emphasizing the importance of engagement and feedback. The primary objective is to enhance the system's effectiveness, making it a valuable tool for SCSEP providers. Users have access to a variety of resources in the Workforce GPS archive, including training webinars, virtual live events, and newsletters, with the latest being the January 2024 Issue 1 Vol 2. The Frequently Asked Questions (FAQ) section is also available for reference before submitting new inquiries.

# Retaining Employment and Talent after Injury/Illness Network (RETAIN)

- 2,600 participants across 76 counties enrolled to date.
- The clinical trial phase of RETAIN ends 5/18/2024, afterwards the program will no longer have a control group and all eligible participants will be able to access services.

## TAA Program Status and Funding

TEGL 07-23 - Ongoing Operations of the Trade Adjustment Assistance (TAA) for Workers Program During Phase-Out Termination has been added to the ETA Advisory database and is now available at <u>TEGL 07-23 |</u> U.S. Department of Labor (dol.gov).

As a reminder, the **TAA** program has funding and continues to serve customers. TAA must be the primary source of funding for customers who are eligible. <u>Previous Partner Express newsletters</u> include articles related to the phased termination that the TAA Program entered on 7/1/22. #### **Virtual Informational Sessions**

Minnesota TAA is hosting virtual informational sessions on January 26 and February 15 for people who may be eligible to apply for TAA benefits under older petitions. The team invites people based on their petition and layoff dates. As always, TAA will refer attendees to enroll in the DW program to access their TAA benefits. #### Tax time

While only Unemployment/TRA and RTAA are taxable income for TAA customers, some students may receive a 1098-T from their training institution. The national TAA office indicates, "The training provider is to report the total cost of the program in Box 1 and Box 5. These amounts should, in nearly all cases should be identical. As such, the amounts would cancel each other out. This would mean the participant is not able to claim any relevant tax credits when filing. It also means the filing individual would not report the amount as excessive income."

# Federal Mileage Rate in 2024

The IRS announced the <u>federal mileage rate</u> for 2024 is 67 cents per mile for those going to training or Job Search. TAA is updating the bi-weekly transportation forms to reflect this new rate. For customers using Relocation Allowance, the mileage rate is 21 cents per mile in 2024.

#### **Petitions**
