Adult Career Pathways Programs

Thank you to those that were able to attend ACP's onboarding sessions in March. It was nice to get out and meet Grantees! As mentioned in these sessions, the team implemented a 30, 60, 90-day check in with Grantees. Your Coordinator will be in touch with you within the first month of your executed contract start date to schedule time to review your program, map out your workforce one activities, and get to know each other. These are being conducted to give Grantees one on one time with their Grant Coordinator, to ask questions, and make sure our Grantees have the tools to understand the components and operate a DEED grant from the beginning.

As part of ACP's partnership with Xcel Energy, 80 participants are graduating from the first cohort of the Xcel Energy Power Up program on May 3rd! Each graduate will have completed work-based learning and moved into union apprenticeship or energy-related construction jobs. This project's goal is to increase diversity in this industry pipeline for a variety of energy-related construction occupations.

Our team continues to review and make recommendations for the Targeted Population Workforce and Clean Economy Equitable Workforce programs. As a reminder the Targeted Populations Capacity Building and Targeted Populations Diversity and Inclusion for Small Employers RFPs are being released as applications and we will accept applications and will award on a quarterly basis until all funds are expended.
