Ability-to-Benefit (ATB):

The ability to benefit (ATB) is a federal financial aid rule that allows students without a high school diploma to qualify for financial aid. Minnesota State and Adult Education are working together to implement a state plan. The goal is to assist an individual in earning their high school diploma and receive financial aid to take career and technical education coursework.

Reminder:

Minnesota has two High School Equivalency (HSE) exams. Many documents and websites still only refer to the GED®. Please use High School Equivalency (HSE) when referring to completing an exam equivalent to a high school diploma.

What is happening in the field:

- Several programs have mentioned having wait lists for learners to enroll in classes.
- Programs are having more beginning literacy students enroll.
- Some programs are having difficulty hiring teachers.
- More employers are connecting with Adult Education providers to offer classes onsite.
